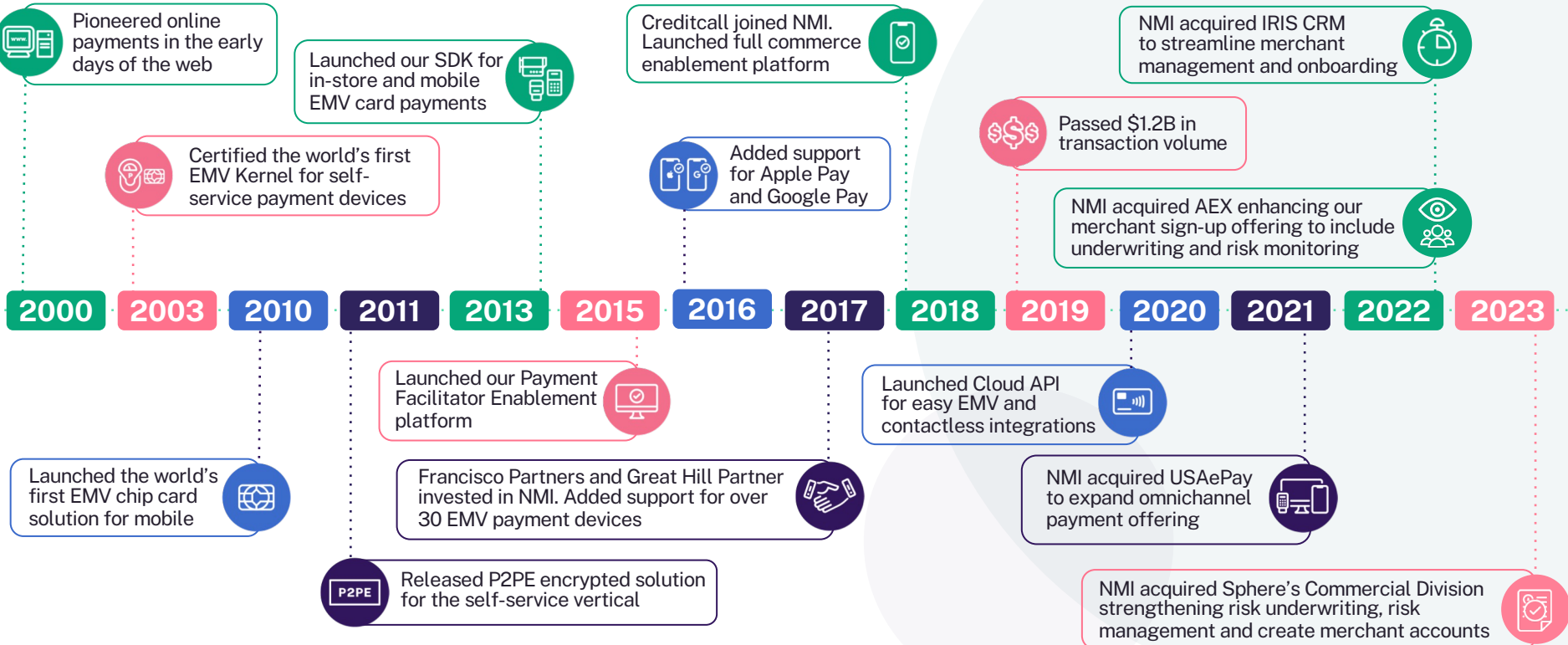

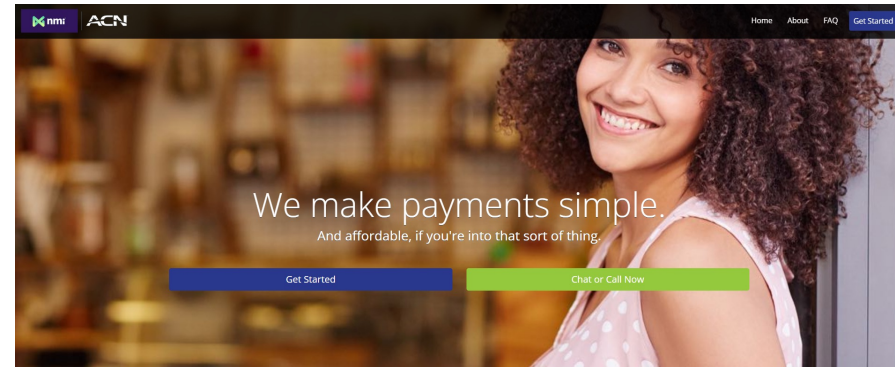


Submitting a Lead

Step 3: Attach their recent EFTPOS statement if you can get one

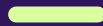

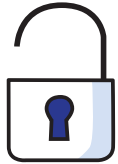

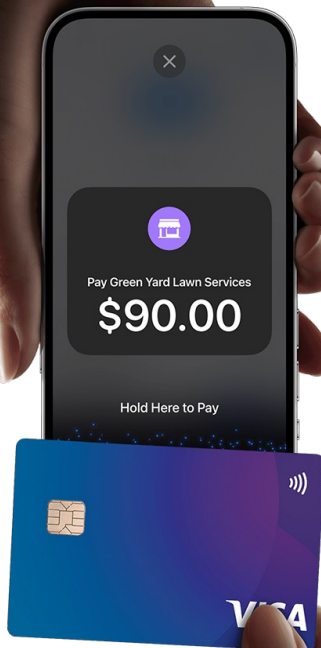
